Twenty (19) member Monmouth County towns and their designated representatives govern the Commission. They meet monthly to establish policy, assure compliance with applicable Federal and State health regulations, as well as the proper management and oversight of all the agency's human resource, business and financial matters. In accordance with State law, the MCRHC employs a licensed Health Officer, who acts as the Administrator. Numerous Registered Environmental Health Specialists perform all required field inspections, complaint investigations, enforcement activities and environmental tasks. The MCRHC interacts with a wide variety of other governmental agencies, elected officials, organizations, community groups and individual citizens. Under the Commissioners and Health Officer, administrative staff is responsible for the documentation of all governing body actions, dissemination of public information and fostering of public relations. MCRHC joins four other local health departments to form the Monmouth Public Health Consortium, providing communicable disease and contract health educator services.

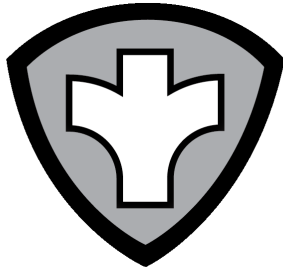

In accordance with Title 8, Chapter 57, Reportable Diseases of the State Administrative Code, disease reports from laboratories and physicians are filed electronically and investigated. Investigations of disease outbreaks and follow-up control measures are initiated as per state guidelines to stop the chain of infection.

A Public Health Nurse provides services supplemented by the Visiting Nurse Association (VNACJ). Flu and Pneumonia clinics are offered each Fall. MCRHC is a service provider for the federally funded VFC/VFA vaccine programs, essentially supporting residents not currently covered by private health insurance. The Nurse performs a portion of the department's vaccine compliance audits in the school populations of several town/town partners. Other responsibilities shared with the VNA are Tuberculosis Direct Observe Therapy (DOT) visits and nurse lead case management for children with confirmed elevated blood lead levels per Centers for Disease Control (CDC).
